- Documents should be uploaded by **5.00 p.m., 7<sup>th</sup> August 2020**.
- Once all documents are uploaded, only then will the verification process will begin.
- All documents should be uploaded in **PDF or JPEG** format only.
- Verification process will take **ATLEAST ONE DAY**.
- After the verification of documents, you will be intimated to pay the fees.
- For B.A. and B. Sc. programs, applicants are required to write their subject preferences clearly. List of subject combinations offered at Mithibai College, is available in the admission notice displayed on the website as well as on the final admission form. Kindly note that subject combination allocation will be as per the availability of seats. The college reserves the right to allocate a particular subject combination to the applicant, other than their preferences, depending on the availability of seats.
- For B.A. and B. Sc. programs, counselling will be held for the offer of subject combination, as per availability of seats. The applicants should be available for counselling after submission of document and up to the last date of current merit list. Counselling will be conducted on MSTeams platform. The link will be sent and applicants have to be join through the link provided at the time specified in the communication for counselling.



- Applicants opting for Microbiology as one of the subjects should have minimum 60% marks for other than Gujarati minority.
- **ELIGIBILITY FOR COMPUTER SCIENCE:** Applicants who do not have Mathematics in class XII are **NOT ELIGIBLE**.
- **ELIGIBILITY FOR BIOTECHNOLOGY:** Applicants who do not have Mathematics in class XII will have to fill an undertaking to complete a bridge course to become eligible.
- Uploading of Class XII-mark sheet (downloaded digital copy Class XII-mark sheet is permitted) and Class X marksheet (scanned original) is **mandatory**. In the absence of the same, **the form will be rejected**.
- In case the applicant's name appears in the categories- Gujarati minority, physically challenged or other reservations, uploading of relevant documents is **mandatory**.
- **In the absence of uploading of the relevant documents as desired, the form will be rejected. No further communication on the same will be sent or accepted.**
- Wherever relevant documents are not available, the applicants must upload an undertaking stating that they will submit documents to the college when the college demands.
- Applicants will have to upload the signed and scanned copy of MKCL form (Pre-enrolment form of the University of Mumbai).
- **The formats for all the undertakings/ declarations are available on the college website.**
