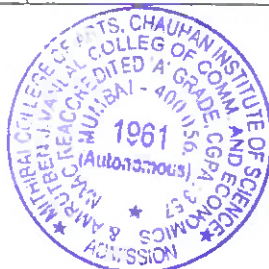

  - School/College leaving certificate.
  - Class X mark sheet (Original for Verification)
  - Transfer certificate (if applicable)
  - Migration certificate (if applicable)
  - Aadhar card
  - For any sports/cultural/defense/ physical disability quota, then relevant documents which justifies claim. (if applicable)
  - Eligibility Certificate: Learners passing from other than Maharashtra state board are required to apply for a provisional Eligibility Certificate through the College to University of Mumbai.
  - Gujarati Linguistic Minority Document (for student seeking admission under Minority category)
    - Original affidavit on Rs.100/. Non-Judicial Stamp paper  
AND
    - ANY one of the following;**
      - Certificate of Community on the letter head with Registration no. of the society.
      - Vasti Patrika with the name of the applicant and family members.
      - School Leaving certificate of any one parent where there is mention of belonging to Gujarati Community.
    - Prima facie letter of eligibility, from University of Mumbai, for Higher Secondary student of International boards
    - Gap certificate (if any) (affidavit on a stamp paper of Rs.100) – Max. 2 years
    - Student seeking admission under Kashmir Migrant Quota should have a letter from competent authority.
