Candidate whose name appears in the Seventh Merit List will have to follow the guidelines as mentioned below:

- 1. Candidate whose name appears in the merit list shall receive an email informing them the process to be completed further.
- 2. Candidates are required to print the Mithibai College admission form along with the all undertakings from link given below or from college website:

- 3. Those candidates who are from Mumbai and their name has featured in merit list are required to come physically for documents verification (As mentioned in Sr. No. 9) After verification of the documents, payment link will be sent on the registered Email ID which needs to be paid ONLINE only within the stipulated time.

Date of Submission of Admission Form & Payment of fees: 18th July, 2024 & 19th July, 2024 between 10.00 a.m. to 1.00 p.m.

- 4. Those candidates who are not from Mumbai and their name has featured in Merit List but not able to come to college for documents verification, should upload document online. The link for uploading the documents will remain open till 18th July, 2024 up to 11.59 p.m. Students should upload the documents (As mentioned in Sr. No. 9) on the following link: https://forms.office.com/r/Cuq9trVYXe in stipulated time only. Extension will not be granted.
 - After uploading all the documents, the verification process begins.
 - All the documents should be uploaded in PDF or JPEG format only.
 - The file for uploading should be named as applicant name_Name of document e.g. Raju Class XII marksheet.
 - Document verification process will take ATLEAST ONE DAY.
 - After the verification of documents, candidate will be intimated to pay the fees through email. The Link for payment will be open till 19th July, 2024; 1.00 p.m.
 - EMI facility will be available for payment till 18th July, 2024.
