- Physically challenged/ learning disability students must select appropriate category from PWD drop down menu.
- Debarred students of Sem-III and IV of the academic 2024-2025 are not eligible for the progression. So, these students should **NOT** attempt to fill online form.
- Semester V students who were debarred during the academic year 2024-2025, will have to secure admission in the same class and complete the term. These students will have to apply to the Principal for the admission. Admission notice for these students is displayed separately.
- Those students who had year drop and now if they are eligible for progression should fill form for the admission in academic year 2025-2026. If they face any technical difficulty then they should immediately report to Vice-Principals.
- Semester VI students who were debarred during the academic year 2024-2025, will have to secure admission in October/November 2025 in the same class and complete the term. These students will have to apply to the Principal for the admission.
- Submission of physical copy of Admission Form with required documents from 28.04.2025 & 29.04.2025 between 10.00 a.m. to 1.00 p.m.

- College Admission form with various undertaking & parent's/guardian's signature and photographs of students & parent/guardian.
- ◆ Copy of Semester I, II, III & IV grade card sheets.
- Copy of Physically challenged/proof of learning disability (by authorized agency) if applicable.
- ◆ Copy of Caste Certificate (if applicable-SC/ST/OBC/NT from Maharashtra State Only).
- Receipt of Online fees payment.
- Self-attestation of all the documents by students is mandatory.
- Students will produce original documents for verification at the time of submission of the physical copy of the form
