FEE REFUND POLICY 2025-26

Process of cancellation of admission is as follows:-

- > Applicant must fill the admission cancellation form available on counter no: 3 & 4.
- List of mandatory documents including Cancellation Form to be submitted for the process of cancellation is as follows:
 - Fee receipt
 - Cancelled Cheque.
- > Admission cancellation will be processed by the College office.
- ➤ Refund will be sent as per the rules and regulations of the Mithibai College adopted from the rules of the UGC (<u>Letter No. D.O.No.F.2-71/2022(CPP-II)(114546)</u>, dated 12th June, 2024)

The following is the fee refund policy as per UGC for the Academic Session 2025-2026:-

- a. Notwithstanding anything contained in any guidelines/ prospectus/ notification/ schedule, a full refund of fees shall be made by the HEIs on account of all cancellations of admissions/migrations of students up to 30 September 2024 and with a deduction of not more than Rs.1,000 as a processing fee, up to 31 October 2024.
- b. For any admission schedule extending/commencing beyond/after 31 October 2024, the provisions contained in the UGC Notification issued in October 2018 on Refund of Fees and Non-Retention of Original Certificates shall apply (reproduced below for ready reference).

| Category | Percentage of Refund of fees* | Point of time when notice of withdrawal of admission is received in the HEI |
|----------|-------------------------------------|---|
| (1) | 100% | 15 days or more before the formally notified last date of admission |
| (2) | 90% | Less than 15 days before the formally notified last date of admission |
| (3) | 80% | 15 days or less after the formally notified last date of admission |
| (4) | 50% | 30 days or less, but more than 15 days after formally notified last date of admission |
| (5) | 00% | More than 30 days after formally notified last date of admission |

c. This policy will remain in force for subsequent Academic Sessions until the issuance of a revised policy by the UGC.
